*Winn Creek Boxers has made every effort to provide you with a healthy puppy. We guarantee this puppy is purebred and can be registered with the AKC. We guarantee that all vaccinations and worming medications are current as stated on the provided vaccination schedule. We encourage Purchaser to have this puppy examined by a licensed veterinarian of their choice within 48 hours of taking possession of this puppy. If the sales transaction takes place on Friday and Monday is a holiday, Purchaser will be given an extra 24 hours to have the puppy examined by a licensed veterinarian. If this puppy is found to have a life threatening hereditary congenital defect or any major health problem at this exam, a replacement puppy of equal value will be given subject to availability (within 12 months), provided that the Breeder is notified within 24 hours after the exam. This puppy must be returned to the Breeder along with the AKC registration papers within 24 hours, at no expense to the Breeder, with a signed document from the licensed veterinarian stating the defect or problem. If the buyer does not take the puppy/dog to a licensed veterinarian within 48 hours from the date of purchase, this warranty becomes null and void. Breeder will not be responsible for any veterinarian bills incurred by the Purchaser. Some disorders may be caused by environmental factors and as such, this guarantee does not include the following: injuries incurred after the puppy has left the breeder, kennel cough, fleas, mites, coccidia, giardia or any other intestinal worms/parasite. This guarantee also does not cover cancer, undescended testicles, uneven bites, umbilical hernias, Class I or Class II heart murmurs, demodectic mange, scabies, allergies and other autoimmune system disorders. Breeder will not be responsible for Parvo, Distemper or Corona Virus after 48 hours of the sale, as these are highly contagious diseases and they can be contracted immediately after leaving the Breeder. Breeder will not be responsible for illness or health problems, which are diagnosed after this time period, except where stated in this contract.*

*Your puppy is guaranteed for one year from the date of birth against life threatening congenital defects. If within that time a life threatening congenital defect (not to include parvo virus, distemper virus, heartworms or any nutrition related disease) is found by a licensed veterinarian, the Breeder will replace the puppy with another puppy of same breed, quality and price. The replacement will be subject to availability (within 12 months). The puppy will be replaced and no moneys will be refunded. The Purchaser must provide, at Purchaser's expense, a written statement from a licensed veterinarian. Breeder will not be responsible for any veterinarian bills incurred by Purchaser. Breeder will not be responsible for illness or any health problems, which are diagnosed after these time periods. In the unlikely event of this puppy's death in the first year, due to congenital defect, a statement from a veterinarian confirming such an event and cause is required before any action will be taken by*

**the Breeder. If cause is unknown, an autopsy is required. The Breeder will not be responsible for veterinary or medical bills incurred by the Purchaser.**

**Your puppy has been on a vaccination and de-worming schedule here and is up to date and these records will be provided to you. Please take these records to your veterinarian, as it is very important to continue with these vaccinations and worm treatments after you take your puppy home. Please do not forget the annual booster after that. You, the Purchaser, agree to insure your puppy's good health and to keep our guarantee in effect by taking good care of the puppy and providing good food, housing and good medical care. Please remember that puppies are babies and they need lots of tender loving care!**

**This contract is valid only for the original purchaser of the puppy from [Winn Creek Boxers](#). If the dog is transferred to another owner this contract is null and void. This contract is null and void if any of the terms and conditions are not fulfilled. If you decide to get full registration (breeding rights) for your dog/bitch, you agree to give me the right to the [first pick of the first litter of pups](#) (free of charge) that your fully registered dog/bitch whelps. In return, I agree to help you choose a good mate for your dog/bitch to be bred to and to help you in any way I can in the breeding process. The Breeder makes no guarantees, expressed or implied, under this contract except as stated above.**

We hope that we have helped you to choose the right puppy for you and your family. If for any reason this puppy does not work out for you, or if your life changes such that you are unable to provide this puppy with a happy home, please call us for assistance in finding him/her a good home.
